
## Rich Site History

















## Transportation Overview

#### Key

- Southbound protected-permitted left turn phasing (green turn arrow) at the Louisiana Ave/Colorado Blvd and Arkansas Ave/Colorado Blvd signalized intersections.
- Dual left turn lanes on the Westbound Arkansas Ave approach to Colorado Blvd.
- Florida Ave and Birch St intersection improvements.
- Vehicular closure of Arkansas Ave between Birch St and the North-South alley.
- Improvements at the Louisiana Ave/
  Bellaire St and Arkansas Ave/Bellaire St intersections with build-out of proposed development.
- Three lane striping of Louisiana Ave and Holly St to provide designated Eastbound and Northbound left turn lanes at the intersection. Reoccurring traffic counts will be conducted.
- Pedestrian and multi-modal use improvements to existing transit and bicycle routes.


